**“IMPLEMENTATION OF CONCRETE ADAPTATION MEASURES TO REDUCE
VULNERABILITY OF LIVELIHOODS AND ECONOMY OF COASTAL
COMMUNITIES OF TANZANIA FINANCED BY ADAPTATION FUND”**

1. This Request for Expression of Interest (EOI) follows the General Procurement Notice (GPN) that appeared in the VPO Website(www.vpo.go.tz),PPRA website and Tanzania Procurement Journal Vol.VII Issue No.38 on 23 September,2014.
2. The Government of Tanzania has received funds from the Adaptation Fund (AF) to implement the Project: **“IMPLEMENTATION OF CONCRETE ADAPTATION MEASURES TO REDUCE VULNERABILITY OF LIVELIHOODS AND ECONOMY OF COASTAL COMMUNITIES OF TANZANIA FINANCED BY ADAPTATION FUND BOARD ”** and it intends to apply part of the proceeds for payments under the contract for consultancy services as follows:
 - i. Coastal Rehabilitation Specialist;

- ii. Sub-Contract Environmental Engineering Firm for Mangrove including Creation of buffer Zones;
 - iii. Mangrove Specialist;
 - iv. Sub-Contract NGO Reef Rehabilitation (Retendered).
3. Under these consultancies , The project aims at reducing vulnerability of ecosystems,infrastructure and economy in Tanzania through implementation of concrete and urgent adaptation measures.The targeted outcomes of the Project are Adverse impact of Sea Level Rise (SLR) and flood on Coastal infrastrucures and settlements are reduced,Coastal Ecosystems are rehabilitated and integrated Coastal Area Management is implemented including Mangrove rehabilitation and knowledge of climate impacts and adaptation is increased.
 4. The Vice President's Office (VPO) now invites eligible individuals/firms consultants to express their interest in providing the services.The interested individuals/firms must provide information indicating that they are qualified to perform the services (brochures,description of similar assignments performed, experience in similar conditions and assignments,availability of appropriate skills among staffs etc).The interested consultants are free to express interest in any of the consultancies listed under para 2 above.
 5. Please note that this is NOT a request for technical or financial proposals.After a review of letters of Expression of interest, a short list will be prepared, and the individual consultant who demonstrate to have more capable of undertaking the assignment will be invited for negotiation and to submit their financial proposals.
 6. **Expression of Interest must be delivered in sealed envelopes by hand or by Courier to the Secretary,Ministerial Tender Board, Vice President's Office , Luthuli street, First floor room no.FF8, wing A by 10:00 hours,local time on 21st February,2015.The outer envelope**

must clearly be marked “” NOT TO BE OPENED BEFORE 21st February,2015”

7. The short listing and final selection of consultants will be carried out in accordance with procedures set out in the Public Procurement Act No. 7 of 2011; and Selection and Employment of Consultants regulations.
